They will be on probation as per rules and will be confirmed on successful completion of probation.

Age:

- 2. TSDPL Employee's Wards Not exceeding 30 yrs. on the date of release of advertisement
- 3. Other Candidates Not exceeding 28 yrs. on the date of release of advertisement

Emoluments:

On selection of the candidates, those with requisite minimum qualification and experience would be placed as "Operation / Maintenance / Service Assistant (Trainee)" in the applicable new grade with zero based DA system and would get medical and other allowances as per applicable terms & conditions. They will be on probation as per rules and will be confirmed on successful completion of probation. Selected Candidates would be covered under Employee State Insurance as per applicable norms; they may also be covered under Company's Insurance Policy as per applicability.

Selected Employee Wards with less than 3 years of minimum relevant experience would be placed at Operation/Maintenance/Service Assistant (Trainee) at a stipend, as notified by the Company, for a period of 1 year. They will not be eligible for other allowances during such period. On successful completion of training, such selected Employee wards will be appointed as "Operation/Maintenance/Service Assistant—Trainee" in the new grade on permanent rolls as per applicable terms & conditions. They will be confirmed on successful completion of probation as per the rules of the Company.

 - g. Service certificate

Eligible applicants who are <u>unable to submit the Resident Certificate</u> will be allowed to undertake the exam/tests under non-resident category.

- 3. Incomplete forms and forms which do not fulfil the criteria will be rejected.
- 4. Last date of submission of application: <u>30th September 2023</u>

Selection Procedure:

- Online written test will be conducted by a Third-Party Testing Agency, followed by background verification and interview by a properly constituted selection committee. Please compulsorily provide your email id.
- 2. Applicants clearing the *minimum cut-off score* in written examination will be called for a *Personal Interview* by a selected panel.
- 3. **Pre-employment medical check-up** for shortlisted candidates who cleared written exam and personal interview.
- **4. Appointment letter** to the selected candidates will be issued only after being found **medically fit** by **TSDPL authorised Medical Institutes/Practitioner**.
